The speaker:

His areas of practice are mainly Corporate Legal Advisory, Conveyancing, Commercial Contracts, Banking Security Documentation, and he also provides corporate legal advice to several private & public companies.

He served as Chairman, Conveyancing Practice Committee (“CPC”) of the Bar Council Malaysia for two consecutive terms (2010/2011) and (2011/2012). He is now the Deputy Co-Chair of CPC having been re-elected for the last two consecutive terms. He is also a member of the Solicitors’ Remuneration Order Enforcement Committee.

Amongst others he is also a member of PEMUDAH Focus Group Registering Property (a Special Task Force under Prime Minister’s Department) monitoring efficiency issues and improvement of public service delivery system intended to enhance Malaysia’s competitiveness in the business environment. He also sits as a panel member of the Legal Profession Qualifying Board Malaysia for the Bahasa Malaysia Qualifying Examination and was appointed to be a member of Solicitor’s Cost Committee pursuant to section 113 of the Legal Profession Act 1976.

He is also currently one of the Presidents for Home Buyers Tribunal appointed by the Minister, Ministry of Urban Wellbeing, Housing & Local Government on 1 Jan 2013.
