He has experience in defending medical negligence matters, accident cases and drafting opinions for insurance companies. He was a member of the Ad-Hoc Committee of Law Revision in the Modernisation of Criminal Procedure started by Hon. Attorney General of Malaysia. He was a member of the Criminal Law Committee of the Bar Council Malaysia and a previous Chairman of the Penang Bar's Criminal Law Subcommittee.
