Synopsis:

This is a talk by 2 High Court Judges about the trial process and trial advocacy. It is a rare opportunity for an interactive, educational and practical session for the members of the Bar who are just entering into the arena of trial.

You will get to understand the Judges' perspective on effective pre-trial case management, trial preparation and execution of the trial strategy.

The speakers will share their thoughts on what Judges expect from counsel handling trials. They will also highlight and illustrate the hallmarks of good trial advocacy.

The speakers:

Justice S Nantha Balan was called to the Malaysian Bar in 1988. He practiced as a trial lawyer for 25 years before joining the Judiciary in July 2013. He will highlight the common mistakes and problems that arise during a trial and will give his views on how a trial should be conducted. He will explain the definition of "good trial advocacy".

Justice Dato' Lim Chong Fong was called to the Malaysian Bar in 1991. He was an active litigation counsel for 23 years. He regularly sat as an arbitrator before he joined the Judiciary in 2014. He will focus on the pre-trial case management aspects of a trial, trial strategy and the "case theory". He will also discuss "court annexed mediation".
