Since then, he has been an active practitioner, specialising in the area of corporate and Intellectual Property with many of his cases being reported in the Malayan Law Journal, Current Law Journal (cljlaw.com) and All Malaysia Reports.

Annou has also been involved in some high profile human rights and constitutional law cases, such as the 3 controversial cases involving the use of the 'Allah' word, the demolition of the Orang Asli place of worship in Temerloh, citizenship cases involving stateless children in Malaysia. He has been invited by Suhakam, NGOs and 'Foreign Spouses Support Group' to give talks and advise on statelessness.
