About the Speaker:

Lalitha Menon graduated from the University of Malaya Law Faculty in 1981. Thereafter she served as a Magistrate in Georgetown for more than 3 years, handling traffic and departmental summonses, civil, criminal, maintenance claims, juvenile cases and death inquests.

During this time, she also lectured and tutored part-time in Law for the Social Worker at Social Science Faculty of Universiti Sains Malaysia in the early 1980s.

Lalitha has been practising as an Advocate and Solicitor for almost 35 years, specialising mainly in civil and family law cases. She is a Certified Mediator of the Bar Council's Malaysian Mediation Centre.

She is a Past-Chairperson of the Penang Bar Committee for 2 terms and past Penang Bar Representative to the Bar Council Malaysia for a further 2 terms. She is a current member of Bar Council Family Law Committee.

Lalitha has been actively involved in the Women's Centre for Change, Penang (WCC) in various roles including its President, Vice-President and Committee member since it was formed in 1985, particularly in the law reform and advocacy work undertaken by WCC.

She was appointed as a Member of the Pardons Board of Penang for past 4 (3-year) terms since 2009 and is also the Legal Advisor of Sri Veeramakaliamman Temple, Jelutong, Penang.
