## **RULES AND REGULATIONS**

### **1. Registration and participation**

- A. Teams shall consist of 5 members. No substitution is allowed without prior approval from the organisers.
- B. This tournament is open for Members of the Bar, Pupils in Chambers, law graduates, full-time employees of law firms, Penang Court Judges and Officers, Penang Court Staff, Legal Officers from Penang State Legal Advisor's Office, Attorney-General's Chambers, Jabatan Bantuan Guaman.
- C. Each team must commit to the time that has been set beforehand by the organisers.
- D. Team names that are found to be offensive/vulgar will not be tolerated by the organisers. Teams that are found not following this rule will be disqualified immediately.

### **2. Tournament Streams**

- A. Teams are not allowed to stream snipe the live tournament stream during the match.
- B. Teams that are found to be abusing the live tournament streams will be disqualified immediately and will be denied any tournament winnings for said action and/or any action that is abusive.
- C. Teams and their respective members are requested to act graciously when the game is streamed. No vulgar words, taunting and/or spamming is allowed. Any dispute arising from the players should be directly referred to the organisers only. Any teams that are found in violation of this rule will be disqualified immediately regardless of whether the game is streamed or not.

### **3. Conduct**

- A. As explained in the above section(s), players/teams must be responsible for each and every team members' actions. Any member within a team that violates the player conduct will be disqualified from entering further qualifiers and the current qualifier that the teams are participating in.
- B. Players must commit to the time/schedule mentioned in the tournament platform. There shall be no personal agreement between Teams as to the time and schedule of the tournament matches.
- C. Players shall not use any form of threats and/or force outside the game to influence the outcome of the games and/or matches played. Severe punishments such as disqualification will be imposed and teams/members in violation of these rules shall also be banned from further tournaments run by the organisers.
- D. Betting and/or fabrication of game match results is strictly forbidden between teams and will not be tolerated.
- E. Agreeing on losing on purpose will also be considered as a disqualification act if found out by the organisers.
- F. Teams are requested to strictly follow the rules and regulations set by the tournament organisers at all times for smooth flow of the tournament.
- G. Any dispute during the Tournament may be referred to the organisers.
- H. Teams that are found not following these conduct rules will be disqualified immediately

#### **4. Tournament Bracket**

- A. No team limit.
- B. All matches will be played online.
- C. The tournament methods will be decided after numbers of participants/ teams have been confirmed
- D. If needed, groups will be separated.

#### **5. Match Rule**

- A. A match refers to the games being played between Team A and Team B.
- B. A game refers to the current game being played between Team A and Team B.
- C. The mobile application to be used is Mobile Legends: Bang Bang (Developer: Moonton).
- D. The game mode used is: Draft Pick.
- E. Match ends – The first team to destroy the opposing team's Base wins, the first team to surrender loses or teams that are found not following the rules are disqualified.
- F. Players shall be responsible for their own network speed and connection and the organiser shall not be held responsible in whatsoever circumstances.
- G. In the case of game crash, the players shall immediately inform the organisers where the game will be paused for a maximum of 5 minutes where all players shall remain in their own base until the relevant players reconnects to the game.
- H. In the case of a server crash, the game can be continued from a new draft but the same hero line-up previously used by the players must be reselected.
- I. In the event of a game exceeding 40 minutes, which leads the organiser to declare a game victory to a team, the deciding factors or criteria in the sequence shall be:
  - (1) The numbers of turrets remaining;
  - (2) The numbers of kills obtained by each team;
  - (3) The worth of golds obtained by each team.
- J. The tournament organisers reserve all rights to any decision made through and for the tournament and/or any matter incidental thereof. The teams and the members thereof shall not have any claims for damages against the organiser.
