To Members of the Penang Bar,

Information Pertaining to Penang Courts during Conditional Movement Control Order period

Reference is made to the announcement by the Government of Malaysia on 7 Nov 2020 on the implementation of a Conditional Movement Control Order (CMCO) for the State of Penang and several other States nationwide from 9 Nov 2020 to 6 Dec 2020 due to the drastic increase in Covid-19 cases.

We have received the following information and directives from Senior Assistant Registrar of the Penang High Court, Puan Diannee Ningrad Binti Nor Azahar and Director of the Penang Courts, Puan Zaharah Binti Hussain with regard to the Penang High Court and Subordinate Courts respectively:

- General directives applicable to all Penang Courts (High Court and Subordinate Courts):
 - o All Penang Courts will remain open with limited workforce and capacity.
 - Filing counters and Commissioner for Oaths at the respective Courts shall continue to operate as usual.
 - However no physical attendance will be allowed at the Courts except for Defence Counsel engaged in Criminal cases involving fresh charges only.

Civil Courts:

- o Trials and Hearings will be converted and conducted online with parties' consent on the existing scheduled dates.
- If parties do not agree to conduct online Trials and Hearings, they must write to Court for adjournments.
- o Members are required to contact the respective Court Registrars (High Court) and Interpreters (Subordinate Courts) for further details and information in relation to cases fixed for physical Case Management/Mention starting Mon, 9 Nov 2020.

• Criminal Courts:

- Only cases involving fresh charges will be heard.
- Trials and Hearings will be adjourned and rescheduled.
- o Members are required to contact the respective Court Registrars (High Court) and Interpreters (Subordinate Courts) for details on rescheduling of cases starting Mon, 9 Nov 2020.
- Cases involving fresh charges at the Georgetown Criminal Magistrate's Courts will only be conducted at Magistrate's Court (2) located at Bangunan Sri Pinang, Jalan Tun Syed Sheh Barakbah.

The contact information of the Subordinate Courts' Interpreters is appended below. The contact information of the High Court Registrars will be provided once we have obtained the same from Court.

Members are therefore advised to take note of the above.
