Update No 3: Information Pertaining to Operation of Penang Courts during "The Total Lockdown Phase 1"

Further to our Circulars Court Liaison 21/21 and Court Liaison 22/21, we have subsequently received the following Notifications from the Penang Courts:-

1) Notifications from the Deputy Registrar (Administration) of the Penang High Court, Tuan Ahzal Fariz Bin Ahmad Khairuddin.

- Notification pertaining to Penang High Courts' operations for Physical Hearing of Matters fixed before the Deputy Registrars and Senior Assistant Registrars titled "*TARIKH BAHARU BAGI KES-KES YANG TELAH DITETAPKAN SECARA FIZIKAL DI HADAPAN TIMBALAN PENDAFTAR / PENOLONG KANAN PENDAFTAR MAHKAMAH TINGGI PULAU PINANG 08 JUN 2021 HINGGA 14 JUN 2021*".

Kindly note that the Schedule for 1 to 7 June was enclosed in Circular [Court Liaison 17/21](#).

- Public Auctions (Manual) will be rescheduled according to the Notification titled "*Makluman Penanguhan Lelongan Awam*". Members are to take note that this is an updated schedule to the one previously enclosed in Circular Court Liaison 21/21.

The said Notifications are appended below for Members' attention and reference.

2) Probate and Letters of Administration matters before Senior Assistant Registrar ("SAR"), Puan Dianee Ningrad Binti Nor Azahar.

- As informed in our Circular [Court Liaison 17/21](#), Probate / Letter of Administration ("LA") matters fixed before SAR, Puan Dianee Ningrad Binti Nor Azahar will be conducted virtually via Zoom. Members are to deposit the Original Documents e.g. Original Will and Original Death Certificate with the Court within fourteen (14) days after the Court is allowed to operate again.

3) Bankruptcy matters

Members are to take note that Bankruptcy matters before Deputy Registrar, Puan Chia Huey Ting and Senior Assistant Registrars, Puan Dianee Ningrad Binti Nor Azahar and Puan Balqis Binti Roslin will be conducted via e-mail. However no Bankruptcy Order will be granted until after Court is allowed to operate.

Orders for any Interlocutory applications will be given by e-mail.

For applications for extension of time, as long as the application is filed before the expiry date, Order In Terms can be given even if the Hearing date has been fixed after expiry date.

Members will be updated further as and when we receive additional information from the Courts.
