### Update No 2: Covid-19 Vaccine Delivery Initiative by Bar Council

References are made to our previous [Circular 15/21](#) and [Circular 16/21](#).

Members and Pupils are requested to take note that a total of 481 Penang lawyers and Pupils registered for the Bar Council's Covid-19 Vaccine Delivery Initiative in 3 separate batches, the breakdown of which is as follows: -

- First batch -125
- Second batch - 314
- Third batch - 42

The Kuala Lumpur Bar Committee (as the National Coordinator of the Bar Council's Vaccine Delivery Initiative) has submitted the above name lists to the Ministry of Science, Technology and Innovation ("MOSTI") as follows: -

- First batch of names was submitted on 24 June 2021
- Second batch of names was submitted on 9 July 2021
- Third batch of names was submitted on 17 July 2021

Those who have registered would have received e-mail updates from the KLBC on the above and related matters.

The Penang Bar Committee has concurrently submitted the said name lists to the *Pengarah Kesihatan Negeri Pulau Pinang* for prioritisation of vaccination.

We have been informed that some of those individuals who registered in the First batch have received their vaccination appointments through the *MySejahtera* app.

Members and Pupils are to take note and be mindful of the following: -

1. Do not delete any previous registration and/or vaccination appointments that you may have received via the *MySejahtera* app as this can cause your name to be removed from the list by the *Pusat Pemberian Vaksin (PPV)*.
2. Anyone who has been advised by their respective Doctors and/or Specialists to only take a specific type of vaccine due to any pre-existing medical conditions are advised to go to *Hospital Pulau Pinang (HPP)* and register for the specific vaccine there. The affected Members and Pupils would be required by HPP to provide the relevant medical and/or specialist reports with a written recommendation for a specific vaccine by their respective Doctor and/or Specialist.

We would like to request that Members and Pupils who have yet to receive their appointments to fill up this [Google Form](#) to facilitate our follow-up with the relevant Authorities.

In the meantime, we are continuing to liaise with the National Coordinator on this matter and Members and Pupils will be updated should there be any further developments.
