Notification from Office of Lands and Mines, Penang (“PTG Penang”) on Temporary Closure of PTG Penang and Rescheduling of Appointments via *Sistem Temujanji Perserahan (STP)* until 13 Aug 2021

We have received an e-mail Notification dated 11 Aug 2021 titled “*Pemakluman Penutupan Sementara Operasi Pejabat Tanah dan Galian Pulau Pinang*” from Encik Mohd Lokman Hakim Bin Syed Sultan, Assistant Director 1 of the Land Title Registration Unit of the Office of Lands and Mines, Penang (“PTG Penang”) informing us that the administration of PTG Penang was instructed to close its Single Point of Contact (SPOC) Counters this afternoon, 11 Aug 2021, for sanitisation and disinfection works to be carried out.
