Shariah compliance is what distinguishes Islamic Financial transactions from Conventional lending transactions where any non-compliance of *Shariah* requirements would generate a "*Shariah* non-compliance risk".

With the increase in litigation cases involving *Shariah* non-compliance issues, it is necessary for litigators to be equipped with the relevant knowledge in this area of practice. Hence, this webinar aims to provide participants with a better understanding of the regulatory, procedural and *Shariah* issues in litigation proceedings.
