### **Information pertaining to Operations of Penang Courts effective 1 Nov 2021**

#### Operations of Courts

The Office of the Chief Judge of the High Court of Malaya has issued a [Practice Direction](#) dated 29 Oct 2021 entitled "ARAHAN AMALAN HAKIM BESAR MALAYA BILANGAN 2 TAHUN 2021 WAKTU OPERASI PEJABAT PENDAFTARAN MAHKAMAH TINGGI MAHKAMAH SESYEN DAN MAHKAMAH MAJISTRET" pertaining to operations of Registration Departments of Courts nationwide effective 1 Nov 2021.

#### Penang Subordinate Courts (Civil)

We have received a Notification pertaining to the hearing of road accident cases at the Penang State Subordinate Courts effective 1 Nov 2021 from Senior Assistant Registrar of the Subordinate Courts, Puan Diannee Ningrad Binti Nor Azahar on instruction from the Director of the Penang State Courts, Dato' Haji Mohd Nasir Bin Nordin entitled "NOTIS MAKLUMAN MENGENAI PENDENGARAN KES KEMALANGAN JALAN RAYA MAHKAMAH MAJISTRET GEORGETOWN (KOD A71KJ DAN A73KJ) DAN KES MAHKAMAH SESYEN SIVIL 1, GEORGETOWN".

Members are requested to take note of the following updates and changes:-

1. Road accident cases bearing case codes A71KJ and A73KJ registered under the Georgetown Magistrate's Court and previously heard by the Georgetown Sessions Court 3 (Civil) will now be heard at the Georgetown Magistrate's Court 1 (Civil).
2. Civil cases ending with digits 7 and 9 [except for adoption cases (code 58)] registered under Georgetown Sessions Court 1 (Civil) will be heard at Georgetown Sessions Court 3 (Civil).

Members are advised to check the E-Filing System ("EFS") regularly for latest updates pertaining to their respective cases.

The said Notification which contains the relevant information and other related details is appended below for Members' attention and reference.

Members are to take further note that Sessions Court Judge, Puan Sharmila binti Abdul Samad will be on maternity leave from 1 Nov 2021 and in her absence, Puan Ooi Sheow Yean has been assigned to hear cases at the Georgetown Sessions Court 3 (Civil). Members may seek clarification and further information pertaining to Georgetown Sessions Court 3 (Civil) cases from the respective Court Interpreters.

Members will be updated further as and when we receive any additional information.

1.1 Semua kes kemalangan jalan raya Mahkamah Majistret (Kod A71KJ dan A73KJ) yang sebelum ini didengar di Mahkamah Sesyen Sivil 3, Georgetown akan didengar di Mahkamah Majistret Sivil 1, Georgetown.
