Notification from Penang High Court: Reorganisation and Addition of Penang High Courts (Civil) effective 29 Nov 2021

We have received a Notification from the Deputy Registrar (Administration) of the Penang High Court, Tuan Ahzal Fariz Bin Ahmad Khairuddin entitled "NOTIS KEPADA MAJLIS PEGUAM PULAU PINANG" pertaining to a reorganisation of the Penang High Courts (Civil) effective 29 Nov 2021.

Members are requested to take note that effective 29 Nov 2021 there will be an addition of 1 Civil High Court which brings the total number of Civil High Courts to 5. The Court's Notification which is appended below provides the relevant details of the 5 Civil High Courts.

Members are further informed that due to the said reorganisation, the Penang High Court is currently in the midst of redistributing and rescheduling Civil cases and the relevant case status updates will be provided in the E-Filing System ("EFS") regularly.

Members will be updated further as and when we receive additional information from the Courts.
