Synopsis:

The webinar will deal with practical aspects relating to written and oral advocacy for the appellate courts. It will focus on practical matters relating to advocacy and how one should approach the preparation and drafting of written submissions for appeals and oral advocacy before the appellate court.

The webinar will also invite participants to think of how to approach an appeal from the point of view of appellant and respondent. It will also cover practical insights into the manner in which counsel ought to prepare for oral arguments and engage effectively with the appellate tribunal.
