Synopsis:

In most matters involving custody of children, divorce and other matrimonial proceedings, Parents of the children will be at loggerheads. They will not be able to see eye-to-eye on this and will usually use the children as pawns in their battle against each other. In this short afternoon, you will be taken through your role as a Lawyer in resolving this matter amicably, where possible.

Then a guide to the drafting of pleadings in the petition relating to the children, the Statement as to Arrangements for Children, the clear prayers that need to be stated which will be reflected in the final Order, the supporting evidence that can be adduced during the trial, the drafting of the Witness Statements, and whether young children can be called as Witnesses. Custody will include Orders as to access to children and related matters. Related issues of Guardianship will be touched on and the relevant statutory provisions will also be highlighted.

The short time may not do justice to the vast topic, but it is hoped that you will be able to learn the practical aspects as much as possible.
