He was the past Chairman of Penang Bar and is currently the Co-Chairperson of Family Law and Personal Injury and Awards Committees as well as the Deputy Chairperson for the Civil Law and Special Areas Committees. He also serves as a member of other Committees in the Bar Council.

He was also appointed as an honorary Legal Advisor to the Council of Justices of the Peace, State of Penang. He is a qualified adjudicator (for construction disputes) and is registered with the Asian International Arbitration Centre (AIAC) in Kuala Lumpur. He is also an Appeal Board Member (Planning) Penang, Advisor at the JP Mediation Bureau, Family Law and Civil Law mediator, Adjudicator, Sports Arbitrator and fellow of the Asian Institute of Alternative Dispute Resolution (AIADR).
