Topics:

- The inquiry to decide whether a person is incapable of managing himself and his affairs
- The appointment, role and capacity of the litigation representative of a "person under disability" under Order 76 of the Rules of Court 2012
- References to "a mentally disordered person" in other laws and statutes
- The general procedure involved in declaring a person to be incapable of managing his/her own affairs
