Penang Bar Futsal Tournament 2023

Tournament Rules

1. Only eligible and registered players are allowed to play in the games. No changes will be entertained after the closing date for submission of the participation form. Each team shall consist of a minimum of 5 players.
2. All fees are not refundable unless the tournament is cancelled.
3. If there are less than 4 teams registered in the category, the tournament will be cancelled and the team captain will be informed prior to the cancellation of the tournament. The fees will be fully refunded to the participants accordingly.
4. If there are more than 5 teams in the category, the games will be played in the round-robin system in the first round(s) and on a knock-out basis thereafter. Otherwise, the games will be played in a league system.
5. In the event of a draw during the knock-out stage, 3 penalties will be taken from each team.
6. Every team is required to wear own jersey/outfit of the team colour during the games to avoid confusion.
7. All players are required to wear appropriate shoes and guards during the play to avoid injury.
8. All games are played at the players' own risk.
9. All decisions made by the referee(s) during the games will be final and no dispute will be entertained.
10. Any serious unsporting behaviour through words or conducts before or during the games will automatically result in disqualification of the relevant player.
11. Besides the above, the International Futsal Rules shall apply subject to any adaption decided by the Convener and communicated to all the teams before
