The said directory and layout plan are appended below for Members' attention and reference.

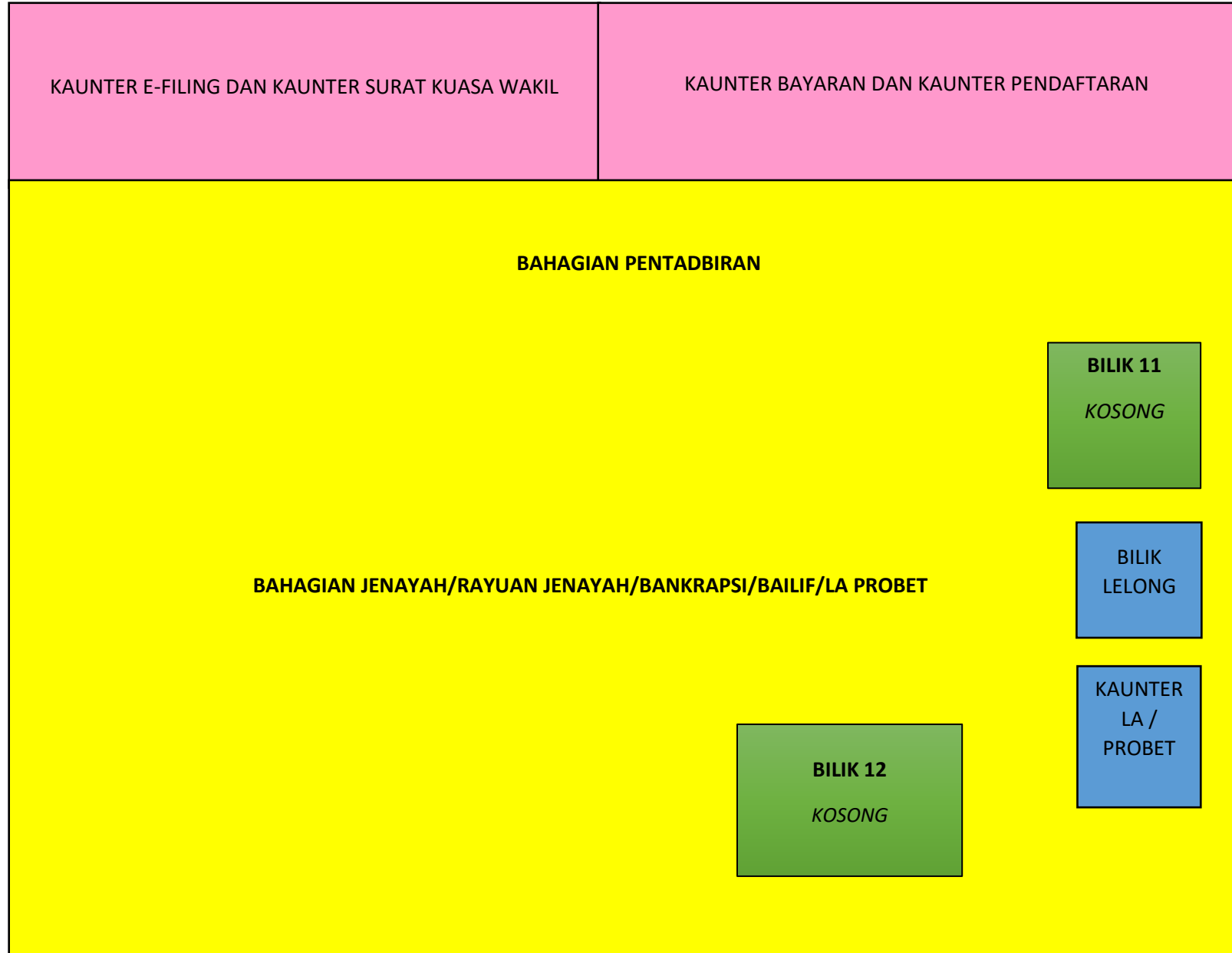

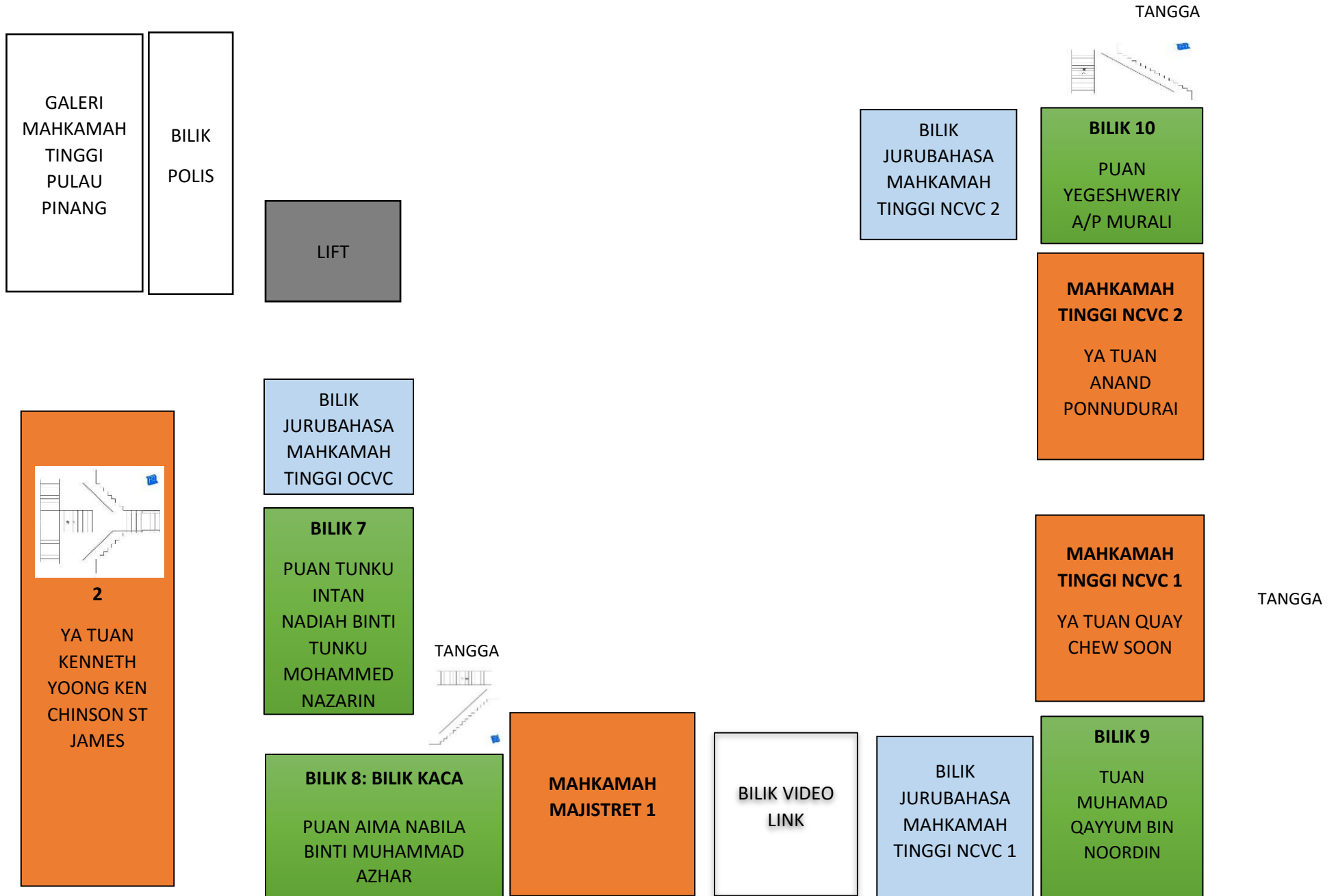

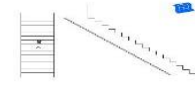
