FAMILY OF JOY!

There is always joy when it comes to being with family. But it is not always a bunch of fragrant roses. Disputes commonly arise on matrimonial matters between spouses [and sometimes a third party thrown in as 'nasi tambah dengan kuah'], children, property, and inheritance of family assets. This talk [or rather an afternoon of family gossip] will take you through some interesting developments that have been taking place through some recent judicial decisions.

Husband and wife agree that 1 of them is allowed to have another partner. Will that be adultery? Or is the consent valid? A third party wakes up one day and claims that a child born to a married woman is his child. Can a DNA test be forced upon the child? Are men better equipped [and more loving?] to look after young children, compared to our earlier generation? If a child is born illegitimate, or, shall we say 'out of wedlock' [wonder if such connotations still make any sense in a modern world], can that child claim for property on intestacy death of a parent? Should a Testator write in his Will that he has already given some assets to his child, hence there is nothing for him in the Will? But why should he do this? Does the per stirpes rule apply in Malaysia? These and a few other issues [if time permits!] will be explored.

Bring along your Distribution Act, Wills Act, Law Reform (Marriage & Divorce) Act, and your problems [not yours but your clients' problems] to discuss. We will have some fun going through these topics.
