Further to our [Court Liaison Circular 15/24](#), [Court Liaison Circular 16/24](#) and [Court Liaison Circular 17/24](#) pertaining to the Relocation of Georgetown Civil High Courts from the Annex Building to the Main Heritage Building, we have received an email from the Deputy Registrar of the Penang High Court, Puan Aziana Binti Azib.

Members are requested to take note that we have received the layout plan of the Penang High Court. The Penang High Court is located in two locations, namely the Civil High Court in the Main Building and the Criminal High Court in the Annex Building. We attached herewith the layout plan for first floor and second floor of the Civil High Court in the Main Building and the layout plan of the second floor of Annex Building for Criminal High Court.

The list of names of the Judges and High Court Officers is the same as the list that was provided in our [Court Liaison Circular 16/24](#) and [Court Liaison Circular 17/24](#). The Court has yet to provide the latest phone numbers in the list of names as the telephone line(s) are yet to be fully functional, the contractor is still in the midst of identifying the problem of the telephone lines and to take necessary action. Members will be further updated as and when we receive the requested information from the Court.

Members are also requested to take note that the Penang Bar Committee for 2024/25 will be having a meeting with Puan Nor Salha binti Dato' Hamzah, Director of Penang High Court and the Judicial Officers on 20 Dec 2024.

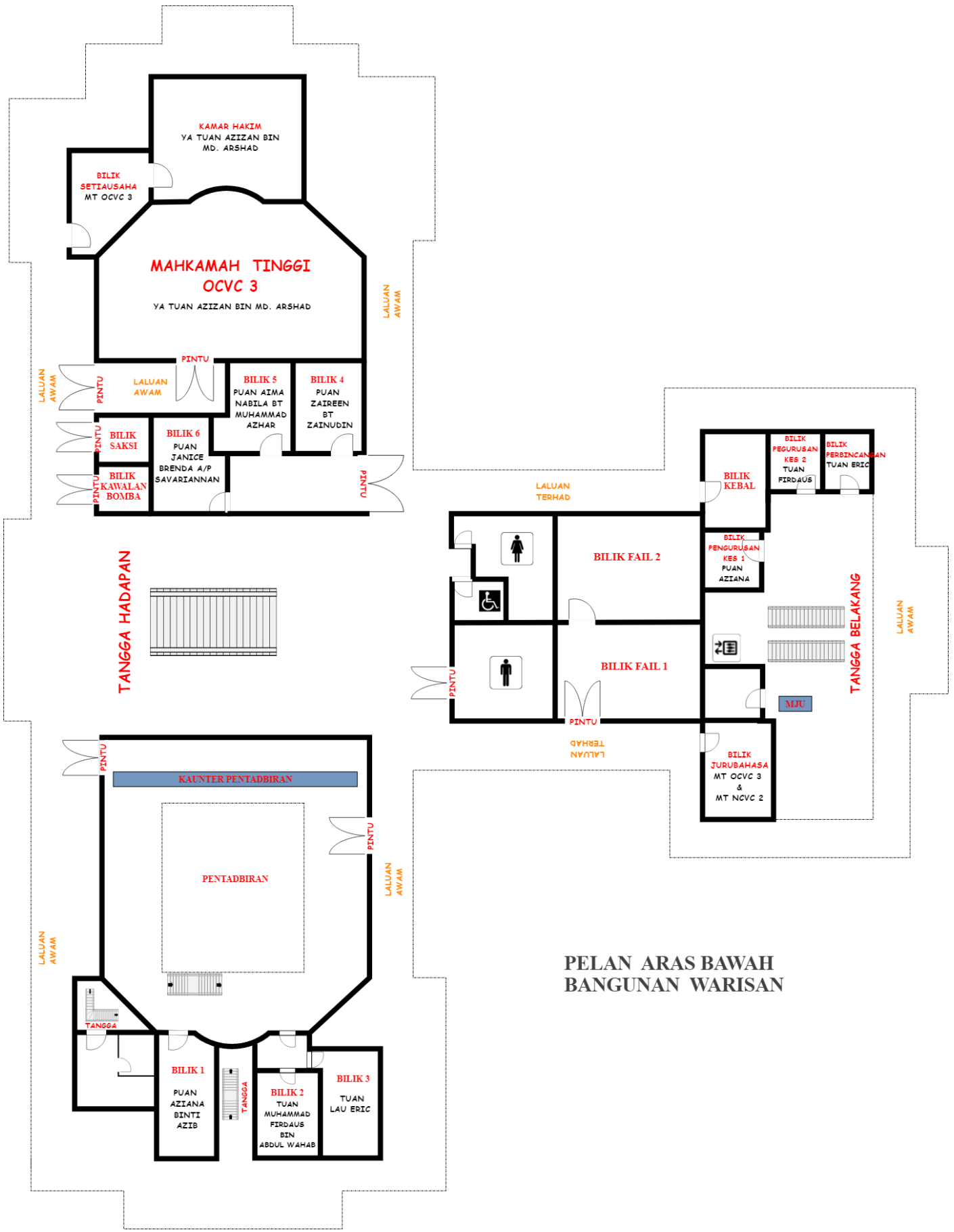

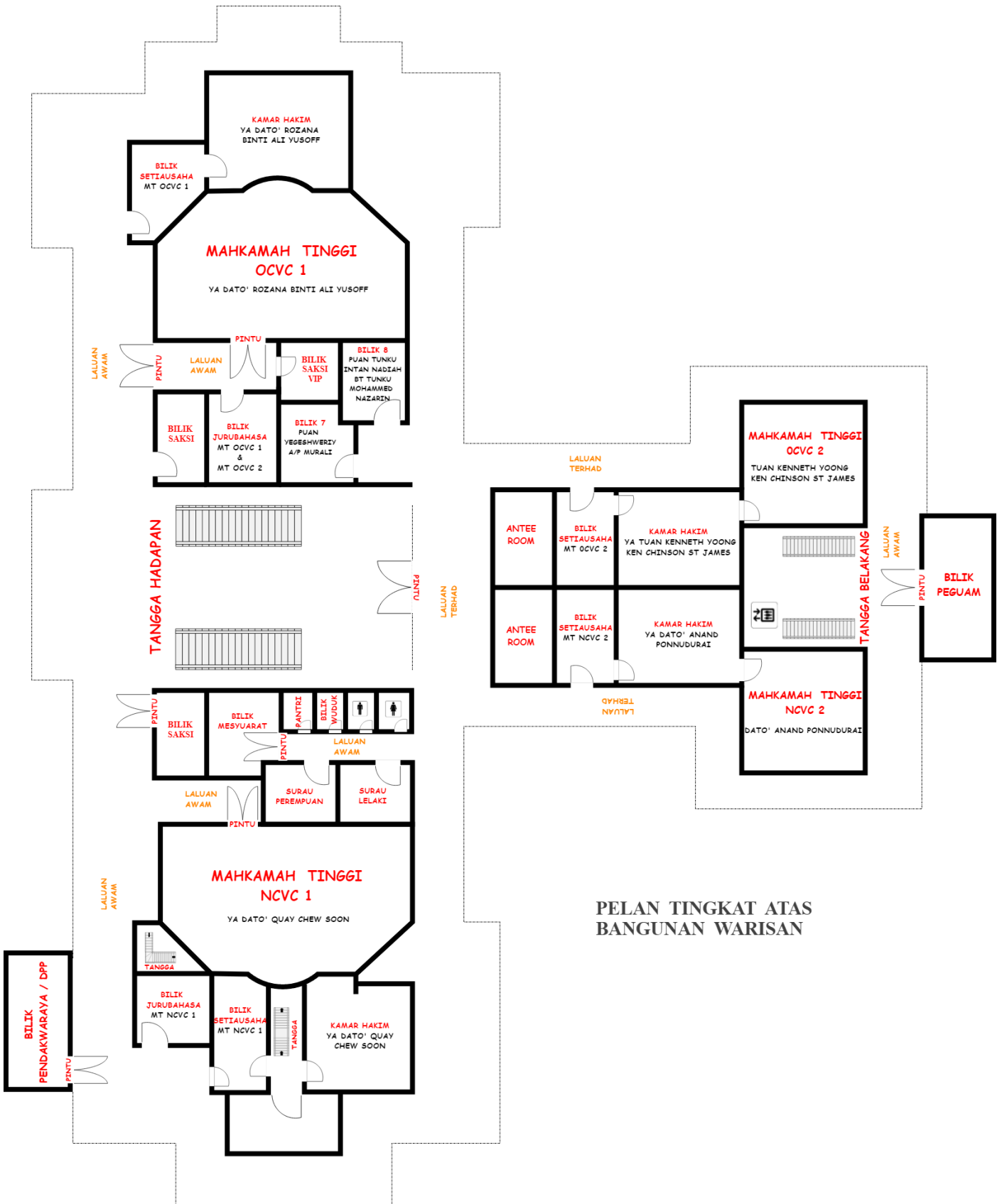
