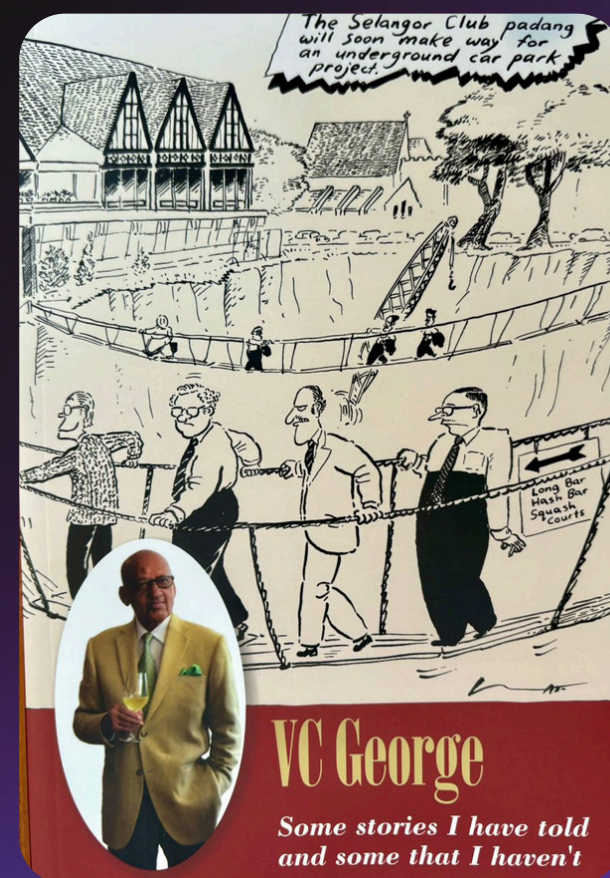

# TAN SRI DATO' V.C. GEORGE

Member of the Bar, Retired  
Judge, an Arbitrator, Recipient  
of the Malaysian Bar Lifetime  
Achievement Award in 2017







## TAN SRI DATO' V.C. GEORGE

Tan Sri Dato' V. C. George was admitted as an Advocate and Solicitor of the Supreme Court of Malaya in 1957 and was in practice for 23 years. During his time with the Malaysian Bar from 1957 to 1980, he practiced in all branches of law, largely concerned with commercial work, and he appeared regularly in the superior Courts as Senior Counsel and occasionally was sitting as an arbitrator in commercial disputes. He served on the Bar Council from 1965 – 1980 and was elected as Chairman of the Selangor Bar in the year 1972 and 1973 and as 8th President of the Malaysian Bar for the term 1974 to 1976.

In year 1981 he was elevated to the Bench of the High Court of Malaya. He was among the first four judges appointed in the newly formed Commercial Division of the High Court in Kuala Lumpur in the year 1983. He was later elevated to Court of Appeal Judge in year 1994 before retiring in December 1995. Thereafter, he has been a Consultant at Messrs. Skrine.

Tan Sri Dato' V. C. George has over a hundred written judgments reported in various law journals. He has also completed over 50 arbitrations (domestic and international) in respect of commercial disputes sitting as a Sole Arbitrator or as a member of the Arbitral Tribunal and / or as Chair of the Tribunal. Tan Sri Dato' V. C. George was the recipient of the Malaysian Bar Lifetime Achievement Award in the year 2017.

Apart from being a profound legal expert, Tan Sri Dato' V. C. George seems to be an excellent storyteller with witty spins. This was perfectly reflected in the book written by him, 'Some Stories I Have Told and Some That I Haven't'. The book consists of humorous stories of his life, friendship and his career as a lawyer and judge.
