## **RULES & REGULATIONS**

### **A. GENERAL**

1. The PENANG BAR PICKLEBALL TOURNAMENT 2025 ("PBPT") is organised by the Penang Bar Committee ("PBC") in accordance with these Rules and Regulations ("R&Rs"). All terms and conditions herein are applicable to all registered Participants.
2. By signing up/registering for the PBPT and submitting personal information to PBC, whether for the purpose of registration or otherwise, you signify that you have read, understood, and agree to be bound by these R&Rs and the Privacy Policy (as published on the Official Website).
3. Registration is only deemed complete upon submission of the registration form and payment of the registration fee, followed by confirmation from PBC.
4. PBC reserves the right to limit or refuse entries without assigning any reason. No substitution of participants is allowed after registration.
5. Participants agree to provide true, accurate, and complete personal details in the registration form and to update such information as necessary. Failure to do so may result in disqualification.
6. PBC reserves the right to amend or update these R&Rs at any time without prior notice. Updates will be posted on the Penang Bar Website at [www.penangbar.org](http://www.penangbar.org) ("Official Website").
7. PBC reserves the right to cancel, postpone, or modify the Tournament without prior notice in the event of unforeseen circumstances. In such instances, reasonable efforts will be made to inform Participants, but PBC shall not be liable for any loss or inconvenience caused.
8. PBC reserves the right to use any photographs, recordings, or media footage of the Tournament (including images of the Participants) for legitimate purposes, including advertising and publicity.

### **B. TOURNAMENT FORMAT**

9. The PBPT is an open mixed doubles event. All Participants will register individually and be randomly paired on the day of the event. Mixed-gender pairings will be prioritised, and same-gender pairings will only be formed where necessary.
10. The Tournament will be held in two stages:
  - **Stage 1: Round Robin** — Pairs will be divided into two groups and will play one match against every other team in their respective groups. The top four pairs from each group will advance to Stage 2.
  - **Stage 2: Knockout** — Qualified pairs will enter a single-elimination bracket. Seeding will be based on group rankings. Winners progress until the final.
11. All matches will be conducted in accordance with the latest official rules of the International Federation of Pickleball (IFP) or USA Pickleball.

---

### **C. SAFETY & LIABILITY**

12. Participants play at their own risk. PBC, its sponsors, and partners shall not be held liable for any personal injury, loss, or damage arising from participation in the Tournament.
13. All Participants are responsible for their own health, safety, and personal belongings. It is recommended that Participants consult a medical professional before taking part in the Tournament.
14. PBC reserves the right to remove any Participant from the Tournament for misconduct, breach of the R&Rs, or any action deemed to be against the spirit of fair play.

### **D. ELIGIBILITY & PARTICIPATION**

15. The PBPT is open to all members of the Malaysian Bar and pupils-in-chambers.
16. Participants must be 18 years and above on the day of the Tournament.

---

### **E. MATCH REGULATIONS**

17. Players must report to the tournament officials at least 30 minutes before the start of the event.
18. Equipment (including paddles and balls) will be provided, but Participants may bring their own paddles, subject to approval.
19. Late arrivals may be disqualified or replaced at PBC's discretion.
20. The decision of the match officials and the organising committee shall be final. No appeal will be entertained.
21. All Participants will receive an e-Certificate of Participation. Winners will receive medals and/or prizes as announced on the Tournament day.

### **F. MISCELLANEOUS**

22. PBC reserves the right to amend the format or rules in the interest of fairness and smooth running of the Tournament.
23. All Participants shall adhere to instructions from the Tournament officials and volunteers.
24. Any form of unsportsmanlike conduct or breach of these R&Rs may result in immediate disqualification.
