Partner at Rahmat Lim & Partners

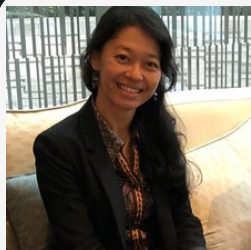
