Topic: Access to Justice - then, now and next

Speaker: Yang Arif Dato' Abdul Fareed Bin Abdul Gafoor

Yang Arif Dato' Abdul Fareed was admitted as an advocate and solicitor of the High Court of Malaya in 1996 and has since practised in diverse areas of law. He previously served as Chair of the Penang Legal Aid Centre and later as Chair of the Penang Bar. At the national level, he held several key positions within the Malaysian Bar, including Co-Chair of the National Legal Aid Committee, Chair of the Malaysian International Mediation Centre, and President of the Malaysian Bar for the 2019/2020 term, being the first President elected from the Penang Bar.

Beyond the Bar, he has also held various appointments, including President of the Strata Management Tribunal, Member of the Anti-Sexual Harassment Tribunal, and Deputy Chairman of the Freedom of Information Tribunal. On 13 August 2025, he was appointed as a Judicial Commissioner of the High Court of Malaya and currently serves in the Criminal Division of the Johor Bahru High Court.
