SSM Penang Survey: Awareness Level on Training Requirements for Company Secretaries

We have received an email from Puan Khairul Nisah Binti Abd Rahman, Corporate Resource Unit, Companies Commission of Malaysia (SSM) dated 26 May 2026 informing us that the Companies Commission of Malaysia (SSM) Penang is currently implementing an initiative to organise awareness programs specifically for Company Secretaries. The objective of this initiative is to assess the training needs and suitability of future training sessions related to the Companies Limited by Guarantee (CLBG) and the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act (AMLA) among corporate professionals.

In relation to this, SSM Penang is currently gathering feedback from various groups of company secretaries to assess their level of awareness and views regarding the obligation to attend CLBG and AMLA training. The findings of this survey will be used as preliminary input to identify training needs and plan appropriate programs in the future.

Members who are also practice or serve as company secretaries are strongly encouraged to participate and provide their feedback. The survey consists of 3 sections and a total of 17 questions.

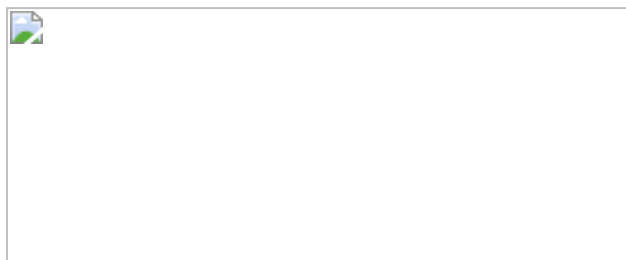

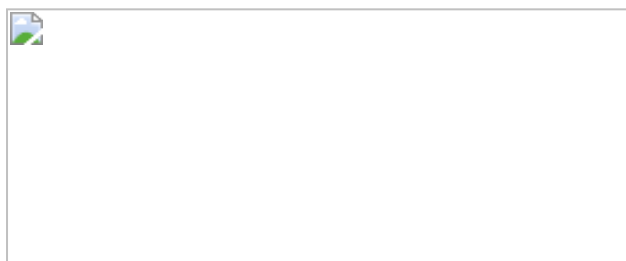
