### **UPDATE: Collection of Donations and Essential Supplies for Flood Victims**

Further to our Circular 19/17, we are glad to note that many members have answered our call for donations and to date, we have received the following:

- Approximately RM6,500-00 worth of various food and drink items such as the ones listed in our Circular 19/17; and
- RM7,700-00 in cash donations.

The packed essential goods items will be available for collection by staff of legal firms from both Penang Island and the mainland from the following addresses beginning 13 Nov 2017 (Mon):

- For Penang island - Penang Legal Aid Centre at No.21 Green Hall, 10200 Penang (Mon – Fri between 9:00am – 4:30pm)
- For the mainland – Imavathi & Co.at No.19-G Lorong Jermal Indah, Taman Jermal Indah, 12300 Butterworth (Mon – Fri between 9:00am to 4:30pm)

Please advise your staff to bring their own boxes or shopping bags to place the items in.

We further inform members that the Committee has decided to stop the collection of essential goods as we are expecting an additional shipment of goods from the Selangor Bar Committee who has been very supportive of our fund-raising efforts.

However we will continue to accept monetary donations which will be handed over to other flood victims so they may purchase whatever necessary items that they require for their homes. Financial aid will also be given to the Penang Bar Committee's Secretariat staff and the Penang Legal Aid staff who were affected by the floods in addition to the food and drink items collected.

We reiterate that monetary donations are to be sent to the Penang Bar Secretariat at No.4 Green Hall, 10200 Penang either by cash or cheque (payable to 'Penang Bar Committee'). Direct bank-in or bank transfer can also be made to the Penang Bar Committee. The Bank details are as follows:
