### **Closure of Main Penang High Court Building**

We hereby refer to a Notification dated 1 Sept 2018 from Puan Zaharah Binti Hussain, Director of the Penang Courts informing members that the main Penang High Court Building will be closed as of 3 Sept 2018 for safety reasons.

Due to this closure, there will be a relocation of Court rooms which involve the Penang High Court, Georgetown Sessions Court and Georgetown Magistrate's Court.

The said Notification is reproduced below for members' information and attention:

6. Semua kes Mahkamah Majistret Sivil 1 akan disebut di Mahkamah Seyen Sivil 2 Georgetown juga di tingkat 7.

7. Semakan kedudukan Mahkamah dan kes untuk Mahkamah Tinggi boleh dibuat di Kaunter E-Filing ( Bangunan Annex ).

8. Semakan untuk Mahkamah Rendah Jenayah boleh dibuat di Kaunter Bahagian Jenayah di Bangunan Annex dan juga di semua Kaunter di tingkat 5 dan 6 Bangunan Sri Pinang.
